**The Organization (1) worked with landowners in its service area to conserve lands with outstanding conservation values through fee acquisition or with conservation easements, completing eight such projects during 2013 (five fee acquisitions, three conservation easements) and advancing several others towards completion; (2) maintained relationships with the owners of the 57 conservation easement properties it holds on 3,456 acres; (3) managed the 2,878 acres of conservation land it owns in fee, ensuring that their conservation values are protected; (4) maintained for public use over 18 miles of walking trails on the properties it owns or monitors; (5) provided public natural history educational programs on its lands that were enjoyed by several hundred participants.**

During 2013, Blue Hill Heritage Trust (BHHT) received "unusual grants" (non-recurring for specific one-time purposes) from Maine Coast Heritage Trust (MCHT) in the total amount of \$867,335. All but \$10,000 of these funds were from a North American Wetlands Conservation Act grant awarded to a MCHT/BHHT conservation partnership project in the Bagaduce River watershed and were used for the purchase of conservation lands. MCHT was the formal grantee and administered the grant. The funds that BHHT received from the grant via MCHT were for lands that it purchased as part of the project partnership. The remaining \$10,000 was a special grant to assist with the implementation of an organizational merger process through which The Conservation Trust of Brooksville, Castine and Penobscot, a neighboring land trust, would be merged into BHHT. (The legal merger was completed in March, 2014)
